Now that you are a member you are free to use the self-service section of the website. It is imperative that you check your email and the web calendar at least once a week to ensure that you and your child know what is going on and when.

PRACTICES AND ATTENDANCE POLICY - All practices are mandatory and additional practices may be called throughout the year depending on performance schedules. Each child is allowed 3 unexcused absences before suspension or dismissal is considered. Unexcused practices are

defined as practices without a doctor's note or school note. Other sports or activities that conflict with Rising Stars practices are NOT excused. Keep in mind your child will be reprimanded for lateness as each instructor deems appropriate (which includes, conditioning, running, pushups or being sat out). Students who have missed warm ups will not be allowed to participate in class for safety reasons. Please remember it takes the entire group to practice dances, routines, tumbling passes, stunts, etc. It is your child's obligation to themselves and their teammates to improve their skills and attend all practices. If you are unsure about your conflicts or absences please contact the director directly.

***(Please review our hand book & attendance policy under the forms section of our website. It applies to ALL members)**

TUITION - FINANCIAL INFORMATION - We are committed to offering the most affordable, yet highest quality program possible. ALL fees MUST be paid in full for your child to participate. ****Tuition is due on the FIRST DAY of each month. **Please ensure payment of your bill by the 10th of each month. Any payments received after the 10th will be subject to a \$20 late fee. Payments made after the 15th will be subject to a \$30 late fee. and your child will be sat out of class.** Accounts must be paid in full in order for your child to participate in class/competitions/performance. Payment is due before services are rendered!

Monthly tuition is as follows: FALL

Classes 30 minute in length - \$55.00/month

Classes 45 minute in length - \$60.00/month

Classes 60 minutes or longer in length - \$65.00/month Multi Child Discount - \$5 off each additional child.

All Access Pass – Take as many classes as you want for \$135/month

All Access Multi Child Discount - \$15 off each additional pass All Access Family Pass - Unlimited classes for \$275/month

Parents attend all half year parent classes for FREE when a child is enrolled in 2 or more classes!!!

All fees are made payable to Rising Stars in the form of cash or check. Checks should be written out to "Holleys Dance Studio". For your convenience you can also pay through our web-site with a credit card. **** There is a \$30.00 fee on all returned checks. **** Please be sure to put your son/daughter's name in the memo line of your check (this is extremely important as some children have different last names as their parents.) If you/your child chooses to leave our organization for whatever reason, **NO MONEY IS REFUNDABLE!**

COSTUMES – ALL full year dance classes that participate in the recital are required to purchase a costume at the rate of \$80 per class. This payment is divided into two payments of \$40 for each costume. The deposit for all costumes is billed on October 1st and the Balance is billed on February 1st. Costume orders will be canceled if your account is not paid in full by March 1st. Rising Stars reserves the right to withhold any costume until balances are paid in full. Customers must allow 24 hours after payment for distribution.

FUNDRAISING AND SPONSORS - You may use the proceeds of the OPTIONAL fall/spring fundraisers to help defray the cost of tuition and uniforms/costumes. All optional fundraising money will be directly deposited into your child's account. Also, all students participating in the recital or receiving an award are **required to sell \$35 worth of boosters and ads for the program booklet.** This amount is due on March 1st and covers the cost of all recital fees, trophies and awards that each child will receive.

DRESS CODE AND EQUIPMENT – Each class is required to follow a specific dress code. This can be found under the "forms" section of our web-site. The dress code ensures that a teacher will be able to see the students body alignment and positioning. It also teaches students discipline & helps with overall focus and energy. The dress code also creates unity among the dancers instead of causing a few dancers to stand out, much like a school uniform policy. You are welcome to purchase your shoes and attire anywhere you wish so long as it is exactly what is listed on the dress code for that class. We sell limited items required in our pro-shop.

COMMITMENT AND RESPECT - Last, but not least, is the commitment that Cheerleading/Dance/Tumbling entails. The Rising Stars program requires dedication, time, support, sportsmanship and respect for you, teammates, coaches and the organization. All of our instructors are 110% dedicated to your child and we expect that same dedication from you and your child. **DISRESPECT WILL NOT BE TOLERATED.** It is imperative that each child and parent be dedicated to their classes and to Rising Stars. It is a big commitment on both the part of the athlete and their families to be a member of any performance program.

Parents are **NOT** allowed inside the practice room unless asked to do so by an instructor. If parents wish to view practice, they must do so from the parents waiting area. Causing a disturbance to the students or parents is not acceptable. We also ask that parents do not pull instructors away from the class to discuss issues, instead please contact the director via email to set up a time to meet the instructor to discuss any issues you may be having. **Any gossiping or bad mouthing about our organization, instructors or students with any parent or student will not be tolerated, and they will be asked to leave our organization without warning. This also applies to rude or disrespectful attitudes toward our members/employees/volunteers of Rising Stars.**

Our instructors reserve the right to dismiss a student from the class if we feel he/she or the parents are not fulfilling this commitment. (Examples: not attending practice, lateness, bad attitudes or anything that would harm the health and welfare of the rest of the group.)

COMMUNICATION - It is the parents' responsibility to stay informed and we are not responsible for "lack of communication" issues. We offer several ways to keep parents informed and up to date including: e-mail, facebook, twitter, Instagram white boards, website calendars, BAND app, printed calendars and newsletters. It is very important that you check one of these regularly.

***PLEASE NOTE - MOST OF THE COMMUNICATION BETWEEN PARENTS AND THE ORGANIZATION IS DONE THROUGH EMAIL, THEREFORE PARENTS EMAIL ADDRESSES ARE ESSENTIAL AND MUST BE KEPT UP TO DATE BY A PARENT.**

Release and waiver of liability

- These risks and dangers may be caused by the action, inaction, negligence or carelessness on the part of the Holley's Dance Studio, LLC. or any of its officers, agents, servants or employees. e) There may be other risks not known to us or not reasonably foreseeable at this time.
